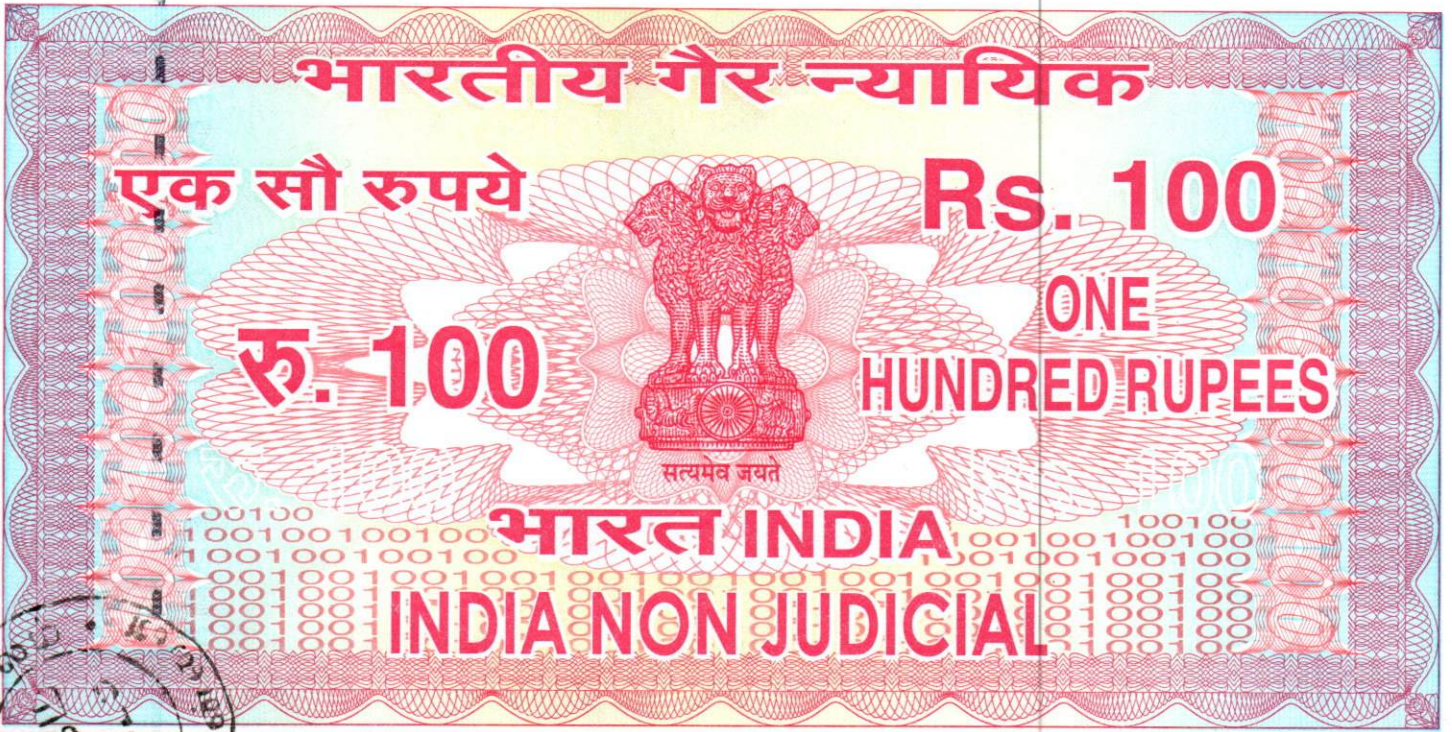

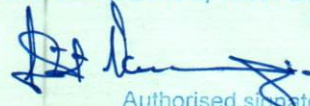

8. That the school will not open classes under CBSE pattern particularly class IX / X / XI / XII and will not use CBSE name in any manner without obtaining affiliation.

9. That the Principal and Correspondent / Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circular issued by the board from time to time. The school undertakes

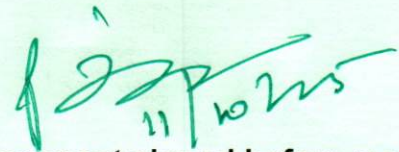
